  2. Second reading of Ordinance 2019-08- An Ordinance adopting an annual budget for the City of Bowie for the fiscal year beginning October 1, 2019 and ending September 30, 2020. Adopting a referenced document as said budget and establishing appropriations for the various activities and functions of the city, establishing an effective date and repealing all ordinances and regulations in conflict herewith.

3. Second reading of Ordinance 2019-09- An Ordinance of the City Council of the City of Bowie, Texas approving a negotiated settlement between the Atmos Cities Steering Committee (“ACSC”) and Atmos Energy Corp., Mid-Tex Division regarding the company’s 2019 rate review mechanism filing; declaring existing rates to be unreasonable; adopting tariffs that reflect rate adjustments consistent with the negotiated settlement; finding the rates to be set by the attached settlement tariffs to be just and reasonable and in the public interest; approving an attached exhibit establishing a benchmark for pensions and retiree medical benefits; approving an attached exhibit regarding amortization of regulatory liability; requiring the company to reimburse ACSC’S reasonable ratemaking expenses; determining that this ordinance was passed in accordance with the requirements of the Texas Open Meetings Act; adopting a savings clause; declaring an effective date; and requiring delivery of this ordinance to the company and the ACSC’S Legal Counsel.
