Second reading of Ordinance 2015-01- An Ordinance providing for a General Election to be held on May 9, 2015 in the City of Bowie; Setting Forth Council Positions and Terms; Establishing Regular and Early Voting Places; Appointing Election Judges; Providing for the use of Direct Recording Electronic Voting Machines; Providing a Proposed Timetable for the orderly processing of events prior to and after the election date; and establishing an effective date.
